3 (New Administrative Regulation)

4 803 KAR 1:081. Board, lodging, gratuities and other allowances.

5 RELATES TO: KRS 337.275, 337.285

6 STATUTORY AUTHORITY: KRS 337.295

7 NECESSITY, FUNCTION, AND CONFORMITY: KRS 337.295 authorizes the commissioner to
8 promulgate administrative regulations permitting allowances as part of the wage rates applicable
9 under the statutes for board, lodging, gratuities, and other facilities. The function of this
10 administrative regulation is to set forth what allowances may be credited toward the payment of
11 wages as required KRS Chapter 337.

12 Section 1. Definitions. (1) “Tip” means a sum presented by a customer as a gift or gratuity
13 in recognition of some service performed. A tip is distinguished from a payment of a charge made
14 for the service.

15 (2) “Tipped employees” is defined in KRS 337.010(2)(d).

16 (3) “Wages” is defined in KRS 337.010(1)(c).

17 Section 2. Board, Lodging, and Other Facilities. (1) In accordance with KRS 337.275 and
18 337.285, an employer may be permitted to include as wages paid to an employee, the reasonable
19 cost of furnishing an employee with board, lodging, or other facilities if they are customarily
20 furnished by the employer to employees.

21 (a) Reasonable cost shall not include a profit to the employer or to any affiliated person.

1 (b) This section shall not prohibit payment of wages in facilities furnished either as
2 additions to a stipulated wage or as items for which deductions from the stipulated wage will be
3 made. The reasonable cost of board, lodging, or other facilities may be considered as part of the
4 wage paid an employee only where customarily furnished to the employee. Not only shall the
5 employee receive the benefits of the facility for which the employee is charged, but it is essential
6 that the acceptance of the facility be voluntary and uncoerced.

7 (2) The criteria for board, lodging, or other facilities being customarily furnished as
8 applicable to KRS 337.275 and 337.285 are as established in 29 C.F.R. 531.31.

9 (3) Other facilities.

10 (a) The criteria for “other facilities” as applicable to KRS 337.275 and 337.285 are as
11 established in 29 C.F.R. 531.32(a).

12 (b) The cost of furnishing facilities which are primarily for the benefit or convenience of
13 the employer shall not be recognized as reasonable and shall not be included in computing wages.
14 Facilities primarily for the benefit or convenience of the employer include, but are not limited to:

- 15 1. Tools of the trade and other materials and services incidental to carrying on the
16 employer’s business;
- 17 2. The cost of any construction by or for the employer; and
- 18 3. The cost of uniforms and of their laundering, where the nature of the business requires
19 the employees to wear a uniform.

20 (4) The prohibition of kickbacks as applicable to KRS 337.275 and 337.285 is as
21 established in 29 C.F.R. 531.35.

22 (5) The criteria for payment where additions or deductions are involved in nonovertime
23 workweeks as applicable to KRS 337.375 and 337.285 are as established in 29 C.F.R. 531.36(a).

1 (6) Overtime workweeks.

2 (a) Pursuant to KRS 337.285, employees shall receive compensation for overtime hours at
3 a rate of not less than one and one-half (1 1/2) times the rate at which the employee is employed.
4 When overtime is worked by an employee who receives the whole or part of his or her wage in
5 facilities and it becomes necessary to determine the portion of wages represented by facilities, all
6 of the facilities shall be measured by the requirements of this administrative regulation.

7 (b) Deductions may be made on the same basis in an overtime workweek as in non-
8 overtime workweeks, if their purpose and effect are not to evade the overtime requirements of
9 KRS 337.285. However, the amount deducted shall not exceed the amount which could be
10 deducted if the employee had only worked the maximum number of straight-time hours during the
11 workweek. Deductions in excess of this amount for the items shall be illegal in overtime
12 workweeks as well as in non-overtime workweeks. There is no limit on the amount which may be
13 deducted for board, lodging, or other facilities in overtime workweeks provided that these
14 deductions are made only for the reasonable cost of the items furnished.

15 (c) Where deductions are made from the stipulated wage of an employee, the regular rate
16 of pay is arrived at on the basis of the stipulated wage before any deductions have been made.
17 Where board, lodging, or other facilities are customarily furnished as addition to a cash wage, the
18 reasonable cost of the facilities to the employer shall be considered as part of the employee's
19 regular rate of pay

20 Section 3. Payment Made to Person Other than Employee. (1) Amounts deducted for taxes.
21 Taxes which are assessed against the employee and which are collected by the employer and
22 forwarded to the appropriate governmental agency may be included as wages. This principle is
23 applicable to the employee's share of Social Security, as well as other federal, state, or local taxes.

1 No deduction shall be made for any tax or share of a tax which the law requires to be borne by the
2 employer.

3 (2) The criteria for payments to third persons pursuant to a court order applicable to KRS
4 337.275 and 337.285 are as established in 29 C.F.R. 531.39(a).

5 (3) The criteria for payments to an employee's assignee applicable to KRS 337.275 and
6 337.285 are as established in 29 C.F.R. 531.40.

7 Section 4. Payment of Wages to Tipped Employees. (1) Conditions for taking tip credits in
8 making wage payments. The wage credit permitted on account of tips under KRS 337.275(2) shall
9 be taken only with respect to wage payments made under KRS Chapter 337 to those employees
10 whose occupations in the workweeks for which the payments are made are those of "tipped
11 employees."

12 (a) To determine whether a tip credit may be taken in paying wages to a particular
13 employee, it is necessary to know:

14 1. What payments constitute tips;

15 2. Whether the employee receives more than thirty (30) dollars a month in payments in the
16 occupation in which the employee is engaged; and

17 3. Whether in the occupation the employee receives these payments in that amount
18 customarily and regularly.

19 (2) General characteristics of tips. (a) To qualify as a tip, the customer shall determine:

20 1. Whether a tip is given;

21 2. The amount of the tip; and

22 3. Who shall be the recipient of the tip.

1 (b) Only tips actually received by an employee as money belonging to the employee which
2 are used as the employee chooses free of any control by the employer, shall be counted in
3 determining whether the employee is a tipped employee within the meaning of the KRS Chapter
4 337 and in applying the provisions of KRS 337.275(2).

5 (3) The following shall not be considered tips:

6 (a) Criteria established in 29 C.F.R. 531.55(a);

7 (b) Where the employment agreement is such that amounts presented by customers as tips
8 belong to the employer and shall be credited or turned over to the employer, the employee is in
9 effect collecting for his or her employer additional income from the operations of the employer's
10 establishment. Even though the amounts are not collected by imposition of any compulsory charge
11 on the customer, the employee is not receiving tips within the meaning of KRS Chapter 337.

12 (4) More than thirty (30) dollars a month in tips. If an employee employed is not a tipped
13 employee, the employee shall receive the full compensation required by KRS Chapter 337 in cash
14 or allowable facilities without any credit for tips received.

15 (a) Pursuant to KRS 337.010(2)(d), the definition of tipped employee does not require that
16 the calendar month be used in determining whether more than thirty (30) dollars a month is
17 customarily and regularly received as tips. A recurring monthly period beginning on the same day
18 of the calendar month may be used.

19 (b) The fact that an employee is part of a group which has a record of receiving more than
20 thirty (30) dollars a month in tips shall not qualify the employee as a tipped employee.

21 (5) The criteria for "customarily and regularly" as applicable to KRS 337.010(2)(d) are as
22 established in 29 C.F.R. 531.57.

1 (6) Criteria for the exception of initial and terminal months of employment from the
2 requirement that a tipped employee receive more than thirty (30) dollars a month in tips is as
3 established in 29 C.F.R. 531.58.

4 (7) The tip wage credit. In determining compliance with the wage payment requirements
5 of the statutes, under the provisions of KRS 337.275(2) the amount paid to a tipped employee by
6 an employer is deemed to be increased on account of tips by an amount equal to the formula set
7 forth in statute provided that the employer satisfies all the requirements in the workweek for which
8 the wage payment is made.

9 (a) This credit is in addition to any credit for board, lodging, or other facilities which may
10 be allowable under this administrative regulation. The actual amount is left by the statute to
11 determination by the employer on the basis of the employer's information taken from his or her
12 records concerning the tipping practices and receipts in the establishment. In order for an employer
13 to take the maximum credit allowed by this special provision, the tipped employee shall receive
14 the maximum in actual tips.

15 (b) If the employee is receiving less than the amount credited, the employer is required to
16 pay the balance so that the employee receives at least the minimum wage with the combination of
17 wages and tips. The tip credit shall be taken only for hours worked by the employee in an
18 occupation in which the employee qualifies as a tipped employee. An employer shall not use any
19 part of an employee's tips to pay the minimum wage to any employee; but may only apply credit
20 toward the payment of the minimum wage to the employee who actually received the tip. Under
21 employment agreements requiring tips to be turned over or credited to the employer to be treated
22 as part of the employer's gross receipts, the employer shall pay the employee the full minimum
23 hourly wage.

1 (8) Overtime payments. When overtime is worked by a tipped employee who is subject to
2 the overtime pay provisions of KRS 337.285, the regular rate of pay is determined by dividing the
3 employee's total remuneration for employment in any workweek by the total number of hours
4 actually worked in that workweek for which the compensation was paid. A tipped employee's
5 regular rate of pay includes the amount of tip credit taken by the employer (not in excess of the
6 formula set forth in statute), the reasonable cost of any facilities furnished the employee by the
7 employer, and the cash wages including commissions and bonuses paid by the employer. Any tips
8 received by the employee in excess of the tip credit need not be included in the regular rate. The
9 tips are not payments made by the employer to the employee as remuneration for employment.


10 (9) Tip pooling. Pursuant to KRS 337.275(2), employees may enter into an agreement to
11 divide tips among themselves. Where employees enter into this type of agreement, the amounts
12 retained by the employees are considered tips of the individuals who retain them. Where an
13 employer requires employees to pool tips, no credit shall be taken and the employer shall pay the
14 employee the full minimum wage.

15 Section 4. Records. Where an employer uses the reasonable cost of furnishing an employee
16 with board, lodging, or other facilities in meeting the requirements of KRS 337.275 and 337.285,
17 it shall be necessary to keep the following records, in addition to those required by KRS 337.320:

18 (1) The facility being provided by the employer to the employee; and

19 (2) The cost being charged for the facility by the employer.


